# Fauna & Flora International

Fauna & Flora International (FFI) saves species from extinction and habitats from destruction, while improving the livelihoods of local people. Our guiding principles are to work with and alongside local partnerships, act as a catalyst for change, make conservation relevant, and base decisions on sound science. Founded in 1903, FFI is the world's longest established international conservation body; our conservation work, and impact, spans the globe.

## Asia Pacific Programme

Working closely with local partners, the Asia-Pacific Programme currently includes a broad range of species and landscape targeted conservation initiatives in Vietnam, Indonesia, Cambodia and Myanmar, and has country programme offices in Phnom Penh, Jakarta, Hanoi and Yangon. Around 70 projects are being implemented in the region by a team of approximately 200 staff, consultants, volunteers and partner organisations with an annual regional budget of approximately USD 10 million.

## Vietnam Programme

Vietnam supports a rich variety of wildlife and habitats, some of which is rare and found nowhere else in the world. Despite its relatively small size, Vietnam is the 16<sup>th</sup> most biodiverse nation on Earth. Vietnam's natural world includes some of the highest diversity of primates (apes and monkeys) in the world, with an incredible 25 species. Vietnam is also a global hotspot for plant, amphibian, reptile and bird richness and endemism.

The FFI Vietnam Programme, established in 1997, is at the forefront of conserving this unique and threatened wildlife and we have experienced some significant successes especially in the recovery of primate populations. Our programme includes a focus on: species conservation; strengthening the protected area network and improving management effectiveness; conservation and connectivity at the landscape scale; supporting the wellbeing of local communities and enabling community-based conservation approaches, placing local stakeholders at the forefront of forest management, protection and monitoring; addressing illegal and unsustainable wildlife trade, and we have recently launched a new marine programme.

## The Opportunity

FFI is seeking a Senior Technical Specialist to provide technical and operational support across the FFI Vietnam Country Programme. As Senior Technical Specialist, you will be a highly experienced conservation professional, and able to take responsibility for the design and implementation of survey and monitoring work (social and natural science), including analysis, data management and reporting.

You will have a strong proven track record in the delivery of technical reports and scientific publications, and provide technical input to programme development and proposal writing. You will be skilled in providing technical advice and input to the design, development, implementation and monitoring and evaluation of conservation outcomes.

You will act as the main conduit for international best practice (including from cross-cutting teams) to enter into and guide the Vietnam Programme's portfolio of work and act as a focal point for research and academic partnerships. The role also requires the provision of support to the Country Director in managing other external relationships i.e. donor communications and reporting and representing the interests of FFI in place of the Country Director where required.

**Working with:**

Project teams; cross-cutting teams (in particular: Analytics, Conservation Technology, MEL, Science & Design, Wildlife Trade); routinely liaise with local government agencies, local communities and community-based organisations, partner NGOs, and national and international academic partners, representing the values and interests of FFI at all times.

**Purpose:**

The Senior Technical Specialist, under the supervision of the Country Director, will lead on technical inputs to all projects of FFI in Vietnam. The position requires working directly with Project Managers and technical staff to ensure effective activity planning to meet technical requirements and ensuring that the deliverables are feasibly completed to standard and in a timely fashion.

**Specific Duties:** Under the line-management of the Country Director, and working closely with project teams and cross-cutting (UK) staff, the Senior Technical Specialist will have the following responsibilities:

**Technical Input**

- Provide technical / advisory input on species conservation across the FFI Vietnam Country Programme (all sites, all project areas), and in all cases further our efforts to conserve biodiversity (especially, but not limited to, threatened primates), including exploring conservation priorities, project design, development opportunities, implementation and ongoing monitoring
- Lead the technical delivery of biodiversity surveys and monitoring, social science surveys, Population Viability Assessments, Conservation Action Plans, species-based and-or ecological research, conservation technology approaches (including Artificial Intelligence, passive acoustic monitoring, Unoccupied Aerial Vehicles and camera-trapping), landscape connectivity assessments, remote-sensing analyses, and other relevant conservation science research
- Lead on the management, analysis and storage of 'big data' (camera trap imagery/videos, acoustic data, drone data, remote-sensing imagery), including the sharing of data with collaborators and partners (as necessary)
- Supervise PhD students (as required) on behalf of FFI
- Act as primary focal point in Vietnam for: UK-based cross-cutting teams (including Analytics, Conservation Tech, ME&L, Science & Design and Wildlife Trade), research and academic partners (including universities, research institutes, and national and international students/interns), and capacity-building and training partners
- Support project staff to understand and apply problem solving logic, ecological and conservation biology principles and scientific rigour, to their daily work tasks and outputs
- Be an expert member of working groups (both internal and external), representing the interests of FFI in Vietnam and furthering the conservation of our focal species
- Take overall responsibility for the production of technical reports and scientific publications (including those done by consultants for FFI) on FFI's work, ensuring scientific rigour and quality, and training and mentoring staff (where possible) to be lead author
- Lead on the procurement of major items of field equipment (e.g. camera traps and similar) by researching options, obtaining competitive quotes and arranging for shipment
- Support protected area law enforcement actions, including technical input to the design and implementation of community-based patrols, SMART software and data collection, and

Conservation Criminology approaches (e.g. Situational Crime Prevention)

- Provide conservation-orientated technical input to the design and implementation of community-based initiatives
- Input to the design of community development / livelihood activities and community education / outreach plans and communication materials (e.g. review of content/fact checking)
- Provide oversight in the field for survey and monitoring work, community patrolling and research projects (as necessary)

### **Programme Development & Reporting**

- Input to project concepts and funding proposals, in line with approved strategic plans and FFI's project cycle
- Help project teams to develop and nurture relationships with prospective and existing counterparts, other NGOs, funders and donors, and hosting donor visits as required
- Lead on or support the development of high-quality donor reports

### **Operational Support**

- Line manage nominated staff through objective setting, continuous performance management, annual appraisal, training provision and personal development planning
- Attend staff / technical meetings on a regular basis to advise the Country Director / Country Programme Manager on challenges, solutions and opportunities relating to project design and implementation
- Support project team members to meet project aims, objectives and timelines, and help ensure that projects are implemented in line with work plans and within budget
- Support the delivery of robust ME&L systems across FFI's portfolio of projects in Vietnam, including providing guidance on appropriate and feasible indicators, producing data summaries and conducting analyses
- Build capacity and mentor staff in the FFI Vietnam Country Programme, by identifying gaps in knowledge, skills or experience, providing training options and materials, supporting the delivery of training, and hosting reading/seminar groups

### **Partnership Development**

- Proactively identify, and where asked, help to develop and nurture relationships and partnerships with third parties, including local government agencies, local communities and community-based organisations, partner NGOs etc.

### **Programme Representation**

- Where asked, represent FFI at key fora, including conferences, consultations, negotiations, meetings, workshops, briefings and in working groups, improving the visibility of FFI's work in Vietnam and elsewhere

### **Communications**

- Bring to the attention of the Country Director any news-worthy items arising within the country programme
- Lead on and support the production of high-quality public reports and journal articles on FFI's work in Vietnam
- Provide editorial review and input to the creation of awareness / PR materials and communication outputs (website text, blogs, social media posts, etc.) to the communication staff (UK and VN)
